MINUTES OF PREVIOUS MEETING

D11/57 The minutes of the meeting held on 4th October were agreed as a true record of the proceedings.

HASA DIVING COMPETITIONS 2011

D11/62 The committee felt the 3m and 5m events were both well attended, with good standard of judging, particularly from less experienced judges.

REVIEW OF EVENTS FROM 2011 / FOR 2012

D11/63 Novice meet felt to be a good event, keep same conditions but RP suggested holding earlier in the year. Proposed date of 4th March 2012, but all competitions dates to be reviewed once have county and national calendars as well.

D11/64 1m/synchro, 3m and 5m/sunchro again felt to be good events, discussion held around altering ages of synchro events but decision made to keep the same, conditions also to remain as they are. Alteration to be made to entry form, to now read "Juniors must be under 19".

D11/65 County age groups events discussed after their removal from the 2011 calendar. Vote taken by committee; three to two in favour of re-instating the age group events. Letters from parents received regarding the matter, these were read to the committee, suggestion made to alter the age group

conditions, to be discussed by coaching members of the committee and proposal put forward.

- D11/66 Masters event discussed by committee, thanks were given to DM for holding a discussion around this at the previous management board meeting. Minutes from management board meeting read to committee resulting in much discussion, but decision made for diving committee to put together proposal for management board and for members of diving committee to attend subsequent management board meeting to discuss the matter further. The proposals will be based around the matters of late entries, medals awarded, and age ranges for the event.
